HEALTH POLICY
OBJECTIVES

Improved affordability of health insurance

Improved health care quality, inclusive of patient safety, effectiveness, efficiency, timeliness of care, patient-centeredness, and equity

Better integration of physical and behavioral health care

Reduced administrative burden and improved clinician wellbeing

## COPAYS FOR SAME DAY PC/BH VISITS

In early 2019, OHIC convened an IBH Work Group to identify potential solutions to several identified barriers to patient access to integrated care

OHIC incorporated these recommendations into the Affordability Standards promulgated 6/25/2020

By January 1, 2021, payers must waive copayments for patients who have a visit with an in-network BH provider on the same day/location as a PC visit at a "qualifying primary care practice"

### FOUNDATIONAL REQUIREMENTS:

"QUALIFYING IBH PRIMARY CARE PRACTICE" A "Qualifying IBH Primary Care Practice" is a PCMH that:

- a. Is recognized by a national accreditation body (such as NCQA) as an IBH practice; or
- b. Currently participating in, or participated in and successfully completed, an IBH program under the oversight of CTC\*; or
- c. Completes a qualifying BH integration selfassessment tool and develops an action plan for improving its level of integration\*

<sup>\*</sup> Practices may use options (b) and/or (c) for up to a total of 3 years
