### **Clinic, Home, and Kiosk Blood Pressure Measurements for Diagnosing Hypertension: a Randomized Diagnostic Study**

For patients with high screening BP in clinic, US Preventive Services Task Force (USPSTF) and other hypertension guidelines recommend follow-up BP testing outside of clinics by 24-h ambulatory BP monitoring (ABPM) or home BP monitoring (HBPM), to avoid overdiagnosis and unnecessary treatment.

# HHS Announces National Competition to Spark Innovation that Will Improve Patient Access to Primary Care

Last week, HHS, through HRSA, announced the launch of [Building Bridges to Better Health: A Primary Health Care Challenge](#), a national competition with a total of \$1 million in cash prizes to encourage innovation through technical assistance (TA) to health centers.

## **Challenge Problem Statement**

Health center patients experience multiple barriers that may reduce access to health care and increase the risk of poor health outcomes due to environmental factors related to health in the places where they live, learn, work, and play. These environmental factors prevent patients from accessing quality primary health care and make it more difficult to address the non-medical, health-related social needs of patients. This Challenge should address barriers to health and health-related social risk factors, such as barriers to accessing medical, social, housing, educational, or other related services.

This challenge will activate and accelerate the development and testing of low-cost, scalable technical assistance (TA) solutions. These solutions will yield resources that HRSA-supported health centers across the country can use or scale to improve health outcomes for their patients. A focus of the Challenge will be to address key drivers of poor health and social determinants of health (SDOH) that contribute to poor health outcomes. Solutions resulting from the Challenge will support health centers to enhance access to primary care and to improve care coordination with other local providers and social service organizations to address SDOH.

The competition is open to broad public participation, including individuals, groups, health care organizations, and other entities.

## Shared Decision-Making and Hypertension Treatment

Shared decision-making is the pinnacle of patient-centered care.
