-Screening measures (GAD-7, PHQ-2/9, and CAGE-AID) will be integrated into standard patient forms	Nurse, medical assistant, midwife, as applicable	Upon arrival at initial OB visit/ At routine prenatal visit if unable to be completed at initial OB visit
-Data will be collected on percentage of initial OB visits in which behavioral health screening measures were administered	Meghan Sharp, Practice Leader	Monthly data collection

Prediction:	Screening will occur at 75% or more of initial OB
	visits across the 10-month cycle

### Aim:

Screen 75% of pregnant or post-partum (PP) for depression utilizing the Edinburgh. Staff/Providers will screen 75% of pregnant or PP for anxiety utilizing the GAD and use the 5P's to screen (75%) for substance use. Currently the sites are screening for depression only at the post-partum office visits. They will standardize the three screenings at least once during pregnancy or PP.	-Providers/ Staff  -Maureen P and Maureen K	January – February start

Screen 100% of pregnant or post-partum (PP) for depression utilizing the Edinburgh. Providers/staff will screen 75% of pregnant or PP for anxiety, utilizing the GAD and use the DAST to screen for substance use. Previously the sites screened for depression only at the PP office visits, but will include using this tool to screen at the initial OB visit which is scheduled with a provider. The sites will work closely with IT department to have the GAD and DAST built into their templates.	-Providers/ Staff	Start January 2020
