## Status Update – Data

- 75% of applicants met the targets/improvement targets for at least 3 out of 4 measures in January
- Payments for qualifying applicants should be received by February 13th
- Applicants that did not meet the targets/improvement targets are still eligible to participate in subsequent quarters (April, July & October)
- Practice Facilitators are here to help

## How has this improved children's health in RI

- RI is #1 in Flu and COVID vaccinations in the nation
- ~12K Kindergarten and 7<sup>th</sup> Graders are immunized by practices participating in this program
- ~6K 2 year olds have received 1 lead screen by practices participating in this program
- ~4K 3 year olds have received 2 lead screens by practices participating in this program



## Status Update – Behavioral Health ECHO

Practices must attend at least 4 out of 6 ECHO® Learning Sessions for psychosocial and behavioral health assessment/intervention to receive July payment. Completed evaluation is required to receive credit for attendance and CMEs. CME credits are available for MDs, PAs, RNs, NPs, Rx, PsyD, and PhDs.

## **Update from RIDOH Lead Program**

### What information should practices send in for results to be entered into KIDSNET

- Analysis Lab
- Last and First Name
- DOB
- Gender
- Full Address include (Apt, unit, floor) city, zip and state (Do not use 101 Friendship St. address)
- Working phone number
- Guardian name
- Language
- Physician (ordering test)
- Draw date
- Test date (date tested at lab)
- Test Method
- PB level (lead level)





## **Update from RIDOH Lead Program**

### What should practices expect - Communication

- When there is incomplete information submitted for data entry, what happens?
  - The lead program will call or fax the practice to follow-up
- What should practices do if they do not have all the data elements needed for data entry?
  - This record will not be able to be entered into KIDSNET until this information is obtained
  - For tests completed out-of-state, the lead program will attempt to assist in obtaining this information. (CLPPP system communication)
  - Practices can also reach out to request additional information from the DOH in the state where testing occurred
  - Testing may potentially need to be re-done
- When are complete records expected to appear in KIDSNET?
  - Four (4) business days from the test date or receipt of data from practice

## **Update from RIDOH Lead Program**

## What response is there from the lead program when there is an elevated lead level?

### For lead levels

- Between  $5 9.9 \,\mu\text{g/dL}$ : A home visit is offered and lead mitigation visit (voluntary)
- Above 10 µg/dL: A home visit is offered and comprehensive RIDOH inspection (voluntary)

### Family Education

- Inspection findings
- Lead exposure prevention
- Communication with landlord

Note: Practices cannot refer to St. Josephs lead center unless screening result is >20 μg/dL






